INSTRUCTIONS TO AUTHORS

- 1. Papers (Laboratory and Clinical Investigations) will be accepted only from members of the Aichi Gakuin Society of Dental Science.
- 2. Only unpublished papers will be accepted.
- 3. If the content of the manuscript to be submitted in this journal requires ethical consideration, describe in the Methods section of the paper how the authors carried out ethical consideration as well as consideration for the research subjects. In particular, state that the authors obtained ethics committee approval and that authors considered protection of personal information. For a case report, approval from the ethics committee is unnecessary, but patient consent is required.
- 4. All conflicts of interest should be disclosed concerning the contents of the paper.
 - AICHI GAKUIN DENTAL SCIENCE Conflict of Interest Disclosure Statement should be submitted.

In addition, one of the following statements should be included in the paper:

- · The authors have no financial conflict of interest to disclose concerning the paper.
- The authors have a financial conflict of interest to disclose concerning the paper, as follows: (please explain).
- 5. Papers will appear in the journal in the order of acceptance.
- 6. All rights in manuscripts shall be transferred to the AICHI GAKUIN DENTAL SCIENCE upon submission.

Submission of a manuscript shall constitute each author's agreement that the AICHI GAKUIN DENTAL SCIENCE holds all proprietary rights in the manuscript submitted, including all copyrights.

- 7. Papers must be written in English.
- 8. Use pica type, double spaced on A4-size paper with 25 mm margins all around.
- 9. On the first page show the title, author's full name, affiliation and location (in italics), key words (three) and the desired number of reprints.
- 10. Example of title, name of author, affiliation and location (in italics):

- 12. List references in the order they appear in the paper. Give author's name and complete title. Add the words (in Japanese) when appropriate. In the case of a magazine, give the author's name, title of article, name of magazine, Volume (in bold font), number, page and year published. Examples:
 - 1. Bertolotti RL, Fukui H: Measurement of softening temperatures in dental bake-on porcelains. J Dent Res, **61**(3): 480-483, 1982.
 - 2. Hisatsune K, Ohta M, Yamane M: Effect of cooling rate on the ordering behavior in CuPt. Dent Mater J, 1(1): 1-7, 1982.
 - 3. Munedhika T: Studies on the adhesion mechanism between the surface of tooth substance and restorative materials. J J Dent Mat, 2(2): 197-231, 1983. (in Japanese)

Note: Abbreviated name of magazines should be those given in PubMed website. In the case of a book, give author's name, edition, name of publisher (place), page number(s) and year.

- 13. Drawings, tables and charts should be self-explanatory.
- 14. Drawings should be done in black or Indian ink on good quality white paper, should be good quality copies done on a copying machine. Pencil is all right when tracings are preferred.
- 15. Each drawing (including photographs) or chart should be on a separate sheet each giving the author's name and serial number. Place of insertion should be indicated in red in the right-hand margin of the main text. Type up a list of all titles and explanations on a separate sheet in the order of insertion.
- 16. Weights and measures should be given using both the JIS-Z 8202 and Z 8203(SI) unit systems.
- 17. Along with the English manuscript, give the title in Japanese, the author's name, affiliation and an abstract (about 400 words).
- 18. Three manuscripts should be submitted: one original and two copies.
- 19. The editorial committee shall decide acceptance or rejection, and classification.
- 20. When the author proofreads, only corrections of differences between copy and proof are permitted.
- 21. Publishing charge is \(\frac{\pmathbb{X}}{20,000}\) per article up to four pages (including charts, drawings and photographs).
 - Additional costs for extra pages, tracings, coloured drawings, coloured photographs, etc. will also be paid by the author.
- 22. Send manuscripts to Aichi Gakuin University Dental Association English Journal Editorial Committee, 1-100 Kusumoto-cho, Chikusa-ku, Nagoya, 464-8650, Japan.
- 23. If possible, the author of accepted manuscripts should supply an exact copy of the final version of the manuscript on a CD.
