## General:

- 2. If the manuscript is classified as an Original article, it is arranged as follows: Title page, Abstract (Background, Methods, Results, Conclusions), Key Words, Introduction, Materials and Methods, Results, Discussion, References
- 3. The abstract is double-spaced and contains no more than 250 words.
- 4. The running title is no more than 40 characters in length.
- 5. There are no more than 5 key words (refer to Medical Subject Heading in MeSH).

## References:

- 1. References are listed as shown in Citing Medicine: The NLM Style Guide for Authors, Editors, and Publishers, 2nd Edition
- 2. When a reference has 7 or more authors, the first 3 authors are named, followed by "et al.". When a reference has no more than 6 authors, all authors are named.
- 3. The references are cited in a proper format consecutively throughout the text.

## Figures and tables:

- 1. Each figure or table is on a separate page (A4).
- 2. Figures and tables are professionally made and easily readable.
- 3. The number of figures and tables does not exceed JNMS rules, as in the chart above.
- 4. Each figure or table is sequentially cited in the text.
- 5. If a paper submitted to JNMS contains figures, tables, or any other part of another article for which the submitting authors hold no copyright, a certificate of permission from the copyright holders is included.

## Publication fees:

- 1. The authors agree to pay the applicable publication fees.

## Instructions to Authors

Authors are requested to follow these instructions carefully. Manuscripts not prepared accordingly will not be accepted.

### General

1. *Journal of Nippon Medical School* (JNMS) is the official journal of the Medical Association of Nippon Medical School and aims to introduce achievements in the fields of basic and clinical medicine. Articles contributed are classified into the following categories: originals, reviews, and case reports.

2. All listed authors of submitted manuscripts must meet the four authorship criteria recommended by the International Committee of Medical Journal Editors (ICMJE):

- (1) Substantial contributions to the conception or design of the work; or the acquisition, analysis, or interpretation of data for the work; and
- (2) Drafting the work or reviewing it critically for important intellectual content; and
- (3) Final approval of the version to be published; and
- (4) Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.

Each author must clearly describe their individual contribution to the submitted manuscript at the end of the text. Individuals who contribute to the preparation of the manuscript but who do not meet all four authorship criteria may be recognized in the acknowledgments section. If any changes are made to the list of authors after initial submission of the manuscript, the editorial committee must be notified after all authors have agreed to the changes.

3. Articles must be submitted in English of a standard appropriate to an international academic journal. Those submitted by non-native speakers of English must be accompanied by certification that they have been edited either by a professional English-language editor or by a qualified colleague (a native English speaker with expertise and experience in the editing of scientific papers). Certificates must be submitted in PDF format together with the manuscript.

4. The articles must comply with the following rules concerning the Protection of Personal Information:

- (1) No information that would facilitate the identification of a patient (name, initials, date of hospitalization, etc.) should be included;
- (2) The general location where a disease broke out may be identified only if it is relevant to the patient's condition;
- (3) The eyes should be blacked out in facial photographs of patients; if photographs of patients with eye diseases are used, the rest of the face should not be identifiable;
- (4) Identifying information such as numbers should be removed from images and from biopsy and autopsy data.

5. Studies reported in contributions to JNMS must be based on humane experimental practices and observe the latest versions of *The Declaration of Helsinki*, *Guide for the Care and Use of Laboratory Animals* or the established guiding principles and standards in the relevant field of research. Papers that describe studies using human or animal subjects must include an Institutional Review Board approval statement in the Methods section. Informed consent should be obtained from all human subjects, and a statement confirming that consent has been obtained must be included in the Methods section.

6. JNMS is designed primarily as a platform for members of

the Medical Association of Nippon Medical School to publicize their research. However, articles may be submitted by other researchers in Japan and around the world.

7. Articles submitted to JNMS implies that it is the original work of the authors, and is neither published before nor is being considered for publication elsewhere. Effective upon acceptance for publication, copyright of the article is transferred to the Medical Association of Nippon Medical School, although all responsibility for its content rests with the authors. A Copyright Transfer Statement by all of the authors must be sent to the editorial office via ScholarOne Manuscripts (<https://www.nms.ac.jp/sh/jnms/declaration.pdf>).

8. Except in the case of articles requested by the Editorial Committee, publication expenses are borne by the author. Authors will be notified of the exact sum.

9. Authors must disclose via the online submission system any financial support or relationships that could be taken to constitute a conflict of interest with respect to the submitted data (<http://www.icmje.org/conflicts-of-interest/>). All such disclosures should be made at the end of the text.

10. Authors must disclose all sources of funding they have received in the manuscript at the end of the text.

11. All clinical trials must be registered prospectively, ideally before informed consent is received from the participants, in a public registry approved by the ICMJE. Authors must provide the name of the registry and the registration number at the end of the abstract. (Secondary data analyses need not be registered separately; the registration number for the primary trial can be used.)

12. The editorial board of JNMS reserves the right to edit any articles accepted for publication as it sees fit.

13. Plagiarism is not acceptable in JNMS submissions. We use the iThenticate plagiarism detection system (Crossref Similarity Check). All submissions are processed via Crossref Similarity Check before being sent for peer review. We reserve the right to reject papers if plagiarism is found during the course of the peer review process. If plagiarism is found after publication, we will issue a correction or retract the paper.

Examples of plagiarism:

- (1) Copying text from other sources without appropriate referencing
- (2) Paraphrasing a referenced text by using basically the same grammar and structure and changing only a few words, even if citations are provided

14. Any articles found to contain plagiarized material or unauthorized duplication of work by other authors will be retracted. Contributors may be requested, at the Editor-in-Chief's discretion, to correct other aspects of the article like data or typographical errors. The Editor-in-Chief will also adjudicate authors' requests for changes to submitted manuscripts, and requests for correction of such minor errors as typographical errors and omissions may not be accepted.

15. Regarding the use of artificial intelligence (AI) in the preparation of materials submitted for publication, JNMS has adopted the following policies:

- (1) AI and AI-assisted technologies should not be listed as authors or co-authors, nor should AI be cited as an author.
- (2) Authors must disclose the use of AI-assisted

technologies in the creation of their work, providing an explanation of how these technologies were used in the manuscript at the end of the text.

- (3) Authors should be able to declare that their paper is free of plagiarism, including any text or images generated by AI. It is their responsibility to ensure that all quoted material is properly attributed, with full citations included.
  - (4) Authors are solely responsible for any content in their manuscript generated by AI and are therefore liable for any violations of publication ethics.
16. Authors should respond to any communications from the Editorial Office within one month of receiving the communication. If the response is delayed, the review process may, at the Editor-in-Chief's discretion, be terminated and the submission treated as withdrawn.

#### Types of manuscripts

1. Originals are scientific reports of unpublished clinical or experimental medical research. The maximum length is 8,000 words, including the title page, abstract, references, tables, and figure legends.
2. Reviews consist of a critical assessment of the literature and existing data. The maximum length is 4,000 words, including the title page, abstract, references, tables, and figure legends.
3. Case reports should have a maximum of 3,000 words, including the title page, abstract, references, tables, and figure legends.
4. Photogravures are brief articles intended to present electron micrographs and images that have clinical or research significance. The maximum length is 200 words, including the title page, references, and figure legends.
5. Letters to the Editor should be brief and contain constructive opinions or questions about articles that have

been published in JNMS. Letters should not exceed 800 words and may include a maximum of 10 references.

#### Arrangement of manuscripts

The entire manuscript, including the whole text, references, legends to figures, tables etc., should be presented as a Microsoft Word file. Manuscripts must be typewritten and double-spaced on paper not exceeding 30×21 cm (standard A4 paper is suitable) with a 3-cm margin.

Manuscripts should be arranged in the following order:

1. title page, 2. abstract and key words, 3. main text, 4. references, 5. figures and figure legends, 6. tables and footnotes, and 7. any other relevant sections. Each of these items should begin on a separate page.

#### 1. Title page

The title page of the manuscript should contain only the following:

- a. Title of the paper (no abbreviations should be used in the title)
- b. Running title (no more than 40 characters, including spaces)
- c. Full names of the authors
- d. Affiliations of the authors (if the publication originates from several institutes, the affiliations of all authors should be clearly stated)
- e. Correspondence address, including telephone and fax numbers, and e-mail address.

#### 2. Abstract and key words

The second page of the manuscript should contain only the abstract (maximum 250 words) and key words. The abstract must be fully comprehensible without reference to the text. For original manuscripts, a structured abstract is required with the following headings: Background, Methods, Results, Conclusions. For other types of manuscript, the abstract should not be structured.

#### Key words

There should be no more than five key words. (Refer to Medical Subject Headings in *MeSH*).

#### 3. Main text

##### Section headings

Manuscripts should be divided into the following sections and presented in this order:

Introduction, Materials and Methods, Results, Discussion, References.

#### Abbreviations

Define abbreviations upon first appearance in the text. Abbreviations should not be used unless they appear at least three times in the text. Avoid jargon and nonstandard usage.

#### 4. References

References should be listed as shown in Citing Medicine: The NLM Style Guide for Authors, Editors, and Publishers, 2nd Edition, published by the United States National Library of Medicine (NLM).

When a reference has 7 or more authors, the first 3 authors must be named, followed by "et al.". When a reference has no more than 6 authors, all authors must be named. Authors using EndNote can format references with the output style below.

References, including those given in table and figure legends, should be numbered sequentially in the order they appear in

the text and listed in numerical order at the end of the manuscript under the heading "References". In the text, the numbers should be set to the right of the reference in superscript, e.g. Rossi-Fanelli et al.<sup>13</sup>/Bennett et al.<sup>24</sup>, etc. Journal titles should be abbreviated as shown in NLM Catalog: Journals referenced in the NCBI Databases.

### 5. Figures and figure legends

#### Figures

All illustrations (line drawings and photographs) are classified as figures. Digital photograph files should have a resolution of at least 300 dpi. Figures and photographs should be numbered in order of appearance with Arabic numerals (for instance Fig. 1, Fig. 2/Photo 1, Photo 2). Each figure must have an accompanying legend, which should be understandable without reference to the text. All of these legends should be collected together on a separate page (typewritten and double-spaced) rather than placed under the figures they refer to. Each figure's position in the text should be clearly indicated.

#### Figure legends

-Legends for all figures should be listed as part of the text document. Please do not write a legend below each figure.  
-Authors are responsible for obtaining permission to reproduce

or modify materials from other sources, including adaptations. Permission letters from the copyright holder of the original source must be submitted with the manuscript.

-The works from which figures are borrowed should be cited in the reference list. A full credit line should be added to the figure legend.

### 6. Tables

-Number tables consecutively in accordance with their citation in the text.

-All tabular material (including footnotes) should be double-spaced.

-Tables (with suitable titles and numbered with Arabic numerals) should be placed at the end of the text on separate sheets (one table per page). They should be understandable without reference to the text.

-Column headings should be kept as brief as possible and indicate units.

-Footnotes should be labeled a), b), c), etc. and typed on the same page as the table they refer to.

-Each table's position in the main text should be clearly marked.

-The same rules governing the use of materials taken from articles of other authors for use in figures apply to materials used in tables also.

### Supplementary Materials

-Supplementary materials can be published in the online version of the journal (J-STAGE). Submissions should be made via ScholarOne Manuscripts, together with the main manuscript. The title and legends should also be submitted in MS Word format.

-Supplementary materials must be limited to 50 MB per file. One figure/table will count as one file, and the maximum number of figures and tables is as stipulated in our submission regulations. For video and audio files, the extensions should be ones that can be played with Windows Media Player or QuickTime, such as mp4 or wmv.

-In order to maintain a link with the printed version, the location of supplementary materials must be clearly indicated in the main text. The link will be maintained through the paper's DOI number.

-Copyright for supplementary materials is transferred to the Medical Association of Nippon Medical School, although all responsibility for their content rests with the authors. In the case of videos, the copyright holder should be clearly indicated at the bottom of the screen. An example is given below.

-Be sure to remove any information that identifies patients, etc. in video or audio files. Any identifying information in the file properties (date and time of recording, location, etc.) should also be deleted. Authors are required to make a consent form showing that both the subject (s) and the person (s) who made the recording are aware that the material will be available for download and have given their approval.

-The publication fee for each video or audio file, payable by the authors, is JPY3,300.

-The editorial board of JNMS reserves the right to request authors to edit any video/audio files if the content or editing of the material is deemed inappropriate.

### Materials used from articles of other authors

If a paper submitted to JNMS contains figures, tables, or any

other part of another article for which the submitting authors hold no copyright, permission must be obtained from the copyright holders. Authors must submit a certificate of permission to JNMS together with their article.

**Publication fees**
