Case reports with opinions in diagnostic pathology are especially welcome, Original articles and short communications in pathologic morphology are also acceptable. Our publication will do it's possible to diminish the limitation to contributors. However, authors are responsible for their content in the articles, as well as the linguistic accuracy.

Style of manuscripts: Each manuscript is to be accompanied by one complete set of illustrations. Manuscripts should be clearly typed in double spacing on one side only of good quality A4 paper(30×21 cm). Margin of 2.5cm should be allowed on all sides.

The typescripts should be arranged as follows, with each section on a separate page.

I. Title page

The title page should contain the article title, author's name(s), institutional affiliation(s), running title is not exceeding 40 letters including spaces), and the name and mailing address of the person to whom proofs, correspondence and reprint requests should be sent.

II. Summary

The Summary should be a concise statement in no more than 120 words. Below the Summary, provide three key words or key phrases or less than three.

III. Main text

The main article, usually 3 pages about 1500 words, could be composed by introduction, case report, pathologic findings, discussion, and references. In case of original article, 6 pages of 500 words/page could be available. All the described papers should be submitted with the CD or FD.

References: Provide a list(no more than ten) of references, double spaced, after the text. Cite references in the text by Arabic numerals in the older in which they appear in the text. In case of original article, twenty references could not be exceeded.

Abbreviate titles of journals according to Index Medicus. Examples are as follows.

Journals:

If the number of authors exceeds six, give the six names followed by et al.

IV. Photographs

They should be created and submitted in acceptable format(TIFF, JPEG, or PDF) with the corrected resolution in a separated file. Figure legends must be submitted for all figures. They should appear on a separate manuscript page after the reference.
