Instructions to Contributors

■ GENERAL POLICY

All authors must adhere to the following criteria.

- 1) JASD accepts review articles, original articles, clinical report and the others.
- 2) Submitted manuscripts must be written clearly and concisely in English and represent unpublished original research that is not being considered for publication elsewhere.
- 3) The journal seeks to publish concise definitive reports of wide interest to the research community and topical, concise reviews of the state of the art.

■ HOW TO SUBMIT MANUSCRIPTS

- 1) **Via mail:** One paper copy of the manuscript and figures plus a floppy disk or CD-ROM (mandatory). The disk/ CD-ROM should contain a word file of the Manuscript text and Tables. Manuscripts must contain separate files (TIFF, EPS, and JPEG,) for Figures.

- 2) Both Macintosh and Windows files will be accepted.
- 3) Any paper manuscripts that are received will be not returned to the author.

■ COPYRIGHT

Submission of a manuscript means that authors automatically agree to assign exclusive copyright to JASD if and when the manuscript is accepted for publication.

■ SUBMISSION CHARGES

JASD has approved a one-time initial manuscript submission fee of ¥5,000. There is no fee for submitting revisions.

■ PAGE CHARGE AND REPRINTS

- 1) Manuscripts over 8 pages are discouraged and any published manuscript over 8 pages will incur extra charges. Page charges for published manuscripts are ¥5,500 per page up to 8 pages. Any pages above 8 will be billed at ¥9,000 per page.

- 2) Reprints can be ordered (by the fifty) by using the Reprint Order Form which is sent to the authors when the page proofs are reviewed by the authors. Pre-payment is required for reprints (See Reprints Order Form in detail).

The authors writing the article by request of the JASD are given 30 free reprints of the articles. If additional reprints are desired, they must be ordered from the Secretariat of IJSD. Reprints will be mailed from 6 to 8 weeks after the article appears in the Journal. Reprints files are not kept by the Editorial Office.

■ NATIVE CHECK CHARGE

A manuscript of non-native authors of English should be proofread by native English speakers before submission. The JASD can introduce the appointed rewriting and translation service company to authors for English manuscript preparation, if needed. Please contact Quintessence Publishing by email, if necessary.

The accepted manuscript will be proofread again by the JASD appointed native English speakers. The authors must pay for native check fee.

Native check price per manuscript page (letter size or A4 size) not including Title page and Abstract.

■ STYLE OF MANUSCRIPTS

General

- 1) Manuscripts should be typewritten with double-spacing (at least 6 mm between lines) on letter size (8-1/2 x 11 inches) or A4 size (21 x 29.5 cm) papers with ample margins [at least 1 inch (2.54cm)] on all four sides, with no indented paragraphs.
- 2) Manuscripts should be clean without tabs and codes.
- 3) Use a standard font such as Times New Roman or Ariel to avoid misrepresentation of your data on different computers that do not have the unusual or foreign language fonts. At least 12-point, type face, neither distorted nor reduced or enlarged, is to be used.

MANUSCRIPT COMPONENTS

The components of a manuscript should be 1) title page, 2) abstract, 3) introduction, 4) materials and methods, 5) results, 6) discussion, 7) acknowledgments, 8) reference, 9) tables, and 10) figure legends. The complete manuscript should be arranged in that order.

Title Page (Page 1.): Complete title. Type in bold type with only the first letters of the main words capitalized. Also, type the first name, middle initial, surname of each contributor in upper-and lower-case letters. Use superscript numbers to relate contributors to different departments or institutions, or to indicate a change in address. For the corresponding who will receive reprint, provide the full postal (including ZIP or Postal Code) and e-mail address, telephone and FAX numbers, as available. If the corresponding author is not the first author, indicate by a number superscript, and use the phrase "corresponding author", and that individual's e-mail address.

A short title (running head) of up to 60 characters, if necessary.

Abstract (Page 2.): not more than 300 words, followed by a list of 1 to 5 key words.

Beginning on page 3: Introduction, Materials and Methods, Results, Discussion, Acknowledgments, Conflict of Interest, References, Table and Figure legends.

4)All pages should be numbered consecutively, the title page being page 1.

REFERENCES

- 1)References should be numbered consecutively in the order in which they appear in the text, and should be kept to a pertinent minimum.
- 2)Identify references in the text, tables and figure legends by Arabic numbers of superscripted letter such as dentistry¹, dentistry^{2,3}, and dentistry⁴⁻⁸.
- 3)Authors use "et al." when the cited work is by four or more contributors.
- 4)Abbreviations of journal names should conform to those of Index Medicus.
- 5)Manuscript accepted but not published may be cited in the reference list by placing "in press" after the abbreviated title of the journal. Also manuscripts written in Japanese or languages other than English may be cited in the reference list; in that case one should add the language (for instance in Japanese, Korean, Spanish, etc.).

■ FIGURES AND TABLES

- 1) Figures and tables should not exceed 8-1/2 x 11 inches (21.59 x 27.94 cm).
- 2) Figures and tables must be discussed thoroughly in the text.
- 3) Figures and tables will generally be printed in column-width, 1-1/2 of column width, and page-width, and thus, all figures and tables should be provided at the optimum size for publication.
- 4) Each figure should be numbered consecutively with Arabic numerals (Figure 1, 2 etc.) and accompanied by a legend clearly describing it. Label the figure number and the first author's name in upright of each figure. The legends for all figures must be typed on 'Figure legends' in text.
- 5) Each table should be clearly titled and provided with a comprehensive legend and numbered separately in Arabic numbers (Table 1, 2 etc.).

■ PROOFS

- 1) Proofs will be sent to authors with manuscript. Only printer's errors must be corrected; no change in, or additions to, the edited manuscript will be allowed at this stage.
- 2) The corrected proofs must be returned within the days when is appointed by member(s) of editorial board.

■ MANDATORY SUBMISSION FORM

The Mandatory Submission Form, which can be found in the journal must be signed by all authors and faxed to the Secretariat (+81 (0)3-5800-7597) upon notification of article acceptance.

■ PERMISSIONS AND WAIVERS

- 1) Permission of author and publisher must be obtained for the direct use of material (text, photos, drawings) under copyright that does not belong to the author.
- 2) Waiver must be obtained for photographs showing persons. When such waivers are not supplied, faces will be masked to prevent identification.
- 3) Permissions and waivers should be faxed along with the Mandatory Submission Form to the Secretariat.

If no conflict of interest is declared, then "None" should be inserted in this section.

Experimental procedures in humans and animals. International Journal of Sports Dentistry endorses the principles embodied in the Declaration of Helsinki and insists that all investigations involving human beings reported in International Journal of Sports Dentistry articles be carried out in conformity with these principles. Authors reporting on their experimental work in humans or animals should also cite evidence in the Method and Materials section of the article that this work has been approved by, respectively, an institutional clinical/human experimentation panel or an institutional animal care and use panel (or equivalent).
